ACCOMMODATION:

LOUNGE/DINER: 17'3" x 10'3" (5.26m x 3.12m). Glazed windows to the front and side elevation. Two ceiling light points. Two wall mounted storage heaters. Storage cupboard. Internal door to: -

KITCHEN: 10'7" x 9'6" (3.24m x 2.9m). Comprising of a range of base and eye-level units with roll edge work surface. Inset stainless steel sink with double-sided drainer. Space and plumbing for oven and washing machine. Glazed window to side elevation. Ceiling light point. Internal door giving access to the property's airing cupboard, which has a lagged immersion cylinder with header tank over.

INNER HALLWAY: Ceiling light point. Night storage heater. Internal doors giving access to:

BEDROOM 1: 10'5" x 8'10" (3.18m x 2.69m). With glazed window to the front elevation. Ceiling light point. Wall-mounted storage heater. Useful storage cupboard.

BATHROOM: Comprises of a three piece suite to include paneled bath, W.C. and wash hand basin. Two obscure glazed windows to the rear elevation. Ceiling light point. Wall-mounted night storage heater.

OUTSIDE: The front of the property sits flush to the pavement. there is a Small area within a shared courtyard.

DIRECTIONAL NOTE: From our office, proceed in a southerly direction on the A6 Leicester Road. At the first set of traffic lights, take a right hand turn onto Southfield Road. Continue along, following the road round to the right then to the left onto Forest Road. At the traffic island junction with Epinal Way, take the third exit. Shortly after the university, at the next traffic island junction, take the first exit onto the A512 as signposted for the M1 and Shepshed. Continue along the A512 and over the motorway traffic island junction into the village of Shepshed. At the first set of traffic lights, take the right hand turn onto Leicester Road. Follow Leicester Road along for some distance and at the mini-traffic island junction, take the second exit onto Kirkhill Road. Proceed down the hill and at the traffic island junction, take the second exit onto Britannia Street where Number 2 can be located on the right hand side.



RESTRICTIONS:

No pets. No sharers. No smokers.

There is no guarantee the Landlord will accept you without them being in receipt of an application form. Ongoing rent is payable calendar monthly in advance by standing order.
